The SPEAKER: The Chair recognizes the Representative from Topsham, Representative Tepler.

Representative TEPLER: Thank you, Madam Speaker. Madam Speaker and Men and Women of the House, good morning. This is LD 1. It's a great bill. In part, this bill does really just one thing. It takes the consumer protections that are currently in federal law in the ACA and it puts them in Maine law. That is all this bill does. It has zero fiscal note. No fiscal note. But it offers to Maine consumers protection against any changes to current law. This includes the preexisting condition exclusion. Under this law, in the State of Maine, preexisting conditions cannot be excluded in insurance coverage. Also, insurers may not establish lifetime caps or limits on the dollar value of your benefits, not lifetime caps and not annual caps. It allows children to remain on their parents' healthcare until they're 26 years old. And it changes the maximum rate differential that can be charged due to age from 4.1 to 3.1 to the benefit of Maine consumers. It's a good bill. Please vote for it. Thank you very much.

The SPEAKER: The Chair recognizes the Representative from Berwick, Representative O'Connor.

Representative **O'CONNOR**: Thank you, Madam Speaker, Ladies and Gentlemen of the House. Take a deep breath. I rise in support of this bill. This bill, LD 1, "An Act To Protect Health Coverage for Maine Families", is appropriately titled. It does exactly what it says; it protects coverage for Maine families. It is likely I may be supporting this legislation from a very different perspective than all but a handful in this chamber. We were here in 2011 in the 125th Legislature and we crafted Public Law 90. It was the Republican Health Reform Initiative. Naturally, a political battle ensued and, in the end, it was a bipartisan vote for a hard-fought win with only a handful of Democrat defectors.

I'm personally darn proud of this work and, much to my delight, those reforms did work and continue to work today. What I see in LD 1 is the preservation of everything we Republicans worked so hard to accomplish in the 125th Legislature on PL 90 together. LD 1 strengthens our choices in our own health insurance needs and preserves the work done on PL 90. Success has been and will continue to be improvement in the individual market rates leveling, perhaps decreasing, more products to choose from that fit our needs, and LD 1 codifies in statute many of the provisions passed in PL 90 and does not undermine any of them.

Representative **SAMPSON**: Thank you, Madam Speaker. Thank you, Ladies and Gentlemen of the House. This bill is about schoolboards and that the folks who vote for them are therefore -- the schoolboard therefore is a representative of the people who elected them. unfortunately, the policy is -- the policy that's stated by Maine's school management basically states that schoolboards in no sense represent the town. After -- now, I'm just taking bits and pieces out of this, so I won't bore you with the details, all the minutiae, but after the election, they are public officers deriving their authority from the law and responsible to the state, not local constituents. However, I would like to draw your attention to the fact that the policy is based on a ruling that was decided back in 1924, and this ruling had nothing to do with schoolboards being representative governing bodies, it actually had to do with a foster child and the ruling on that foster child. So it was essentially a cherrypicked piece out of that ruling that has now become policy in our local schoolboard policies. So, the reason this bill is before us is because parents whose children are in the school are very frustrated by the fact that their schoolboards aren't listening to them and they've been told that they don't have to listen to them. They can come to the public comment period, make their comments, but they don't have to be listened to. So. I would ask that we would vote Ought Not to Pass.

Another training was by Maine School Management and they had a different take on that. So, we voted Ought Not to Pass, some of us voted Ought Not to Pass with the stipulation that we send a letter to DOE to sort this out and to send schoolboards a model of exactly who their constituency is.

The SPEAKER: The Chair recognizes the Representative from Belgrade, Representative Keschl.

Representative **KESCHL**: Yes, we're a representative republic and when people vote for people, ultimately the people are responsible that elect them. So, I don't get the ruling and stuff, but as far as the policy goes, in my view, the people are their -- the schoolboard people that are elected are elected to represent their constituents and they should be listening to their constituents and the constituents can vote them out of office at any point in time.

The funds would be matched by grants and private donations. Our maritime heritage is an underutilized but valuable resource for communities and for tourism. As these destinations become more accessible, the multiplier value of dollars makes this a valuable investment. When historic resources are lost, they are lost forever. I urge you to vote in favor of this bill and follow my light. Thank you.

The SPEAKER: The Chair recognizes the Representative from Alfred, Representative Sampson.

Representative **SAMPSON**: Thank you, Madam Speaker and Ladies and Gentlemen of the House.
