**JOINT RESOLUTION RECOGNIZING MAINE'S REALTORS**

WHEREAS, the Maine Association of REALTORS® has more than 6,200 members actively involved in the business of real estate and it has approximately 400 affiliate members, including lenders, appraisers, title companies, building inspectors, surveyors and insurance providers; and

WHEREAS, the not-for-profit trade association provides each member with an equal voice and representation in the real estate profession, serving members in all 16 Maine counties and in their communities; and

WHEREAS, a healthy supply of affordable, safe, secure and high-quality residential and commercial real estate inventory statewide supports the continuing growth of Maine's economy; and

WHEREAS, real estate transactions stimulate Maine's economy and include not only the money spent and reinvested in the sale price of a property but all those services and expenditures that occur in relation to a property transaction, for both a buyer and a seller; and

WHEREAS, according to national statistics, it is estimated that one job is generated for every 2 home sales, each home sale contributes about \$146,000 to the economy and the real estate industry accounts for 18.6% of the gross state product; and

WHEREAS, the real estate market in Maine is strong, as evidenced by the number of home sales and the overall impact on Maine's economy in 2022 of 15.7 billion dollars; and

WHEREAS, real estate ownership is an investment in the future and one of the best ways to build financial security through equity accumulation, and for many in Maine their real property ownership represents their life savings; and

WHEREAS, expanding real property ownership will strengthen our State and its families and communities, enhance our economy and create jobs; now, therefore, be it

RESOLVED: That We, the Members of the One Hundred and Thirty-first Legislature now assembled in the First Special Session, take this opportunity to recognize the Maine Association of REALTORS® and its members for their positive contributions to and the significant role they play in the lives of Maine citizens and their communities and that their service and dedication to this State are a tribute to those values and principles that we all hold dear; and be it further

In 1988 she founded the Delaware Valley Grantmakers, now known as the Philanthropy Network of Greater Philadelphia, and served as the organization's director. In 1995 she moved to Maine, becoming the founding Executive Director of the Maine Philanthropy Center and serving in that position until 2001. For over 60 years, she was active with Bay Chamber Concerts, serving as Board President from 2016 to 2021 and as a member of the development committee for over 20 years. She also helped to create the plan and the financial model for the Bay Chamber Music School, which opened in June 2010. Representative **DOUDERA**: Thank you, Madam Speaker, Men and Women of the House. I had a nice chat with Sani Fogel in the fall when I was knocking on doors in Rockport Village. She met me at her door and she introduced me to an adorable and rambunctious springer spaniel puppy that she had named Minnie. But she also wanted to talk about issues such as affordable housing, sea level rise and our workforce shortage. She asked questions, she gave me ideas. This was a woman who cared deeply about her town and our State right up until her death in February at the age of 86.

As you heard in the sentiment, Sani had two big loves; the arts and community. She grew up surrounded by classical music. Her grandmother was a well-known Russian-born violinist, just one of many relatives who were professional musicians. She was introduced to the arts and philanthropy by an older generation of pioneering female relatives and thinking of these strong female connections and her two daughters who are here with us today, I reached out to a number of women in my community to ask them about their favorite Sani Fogel memories.

Linda Clancy, editor at the PenBay Pilot says; Sani loved Maine and was dedicated to her Rockport-centered community. She served two three-year terms on the Town of Rockport Select Board and volunteered on multiple committees. She was both a leader and a consensus builder, always eager to hear new ideas.

Rockport resident Nancy said; I had the pleasure of knowing her when we served on the Opera House Committee. I'm glad I got the chance to work with her. She's a wonderful example of Rockport community spirit.

Sani had a giant impact on the Mid-Coast Organization Bay Chamber concerts. As her friend Monica Kelly said; Sani was one of a kind in her devotion, her passion and her indomitable spirit. She left her mark on so many aspects of our organization, from concerts to school to leadership and as an ambassador and champion for all we do. We will treasure her memory always.

My friend Sara said; I will always remember the red lipstick she wore to work out at the Y. So chic.

The Honorable Joan Welsh, who served in this Body, commented on Sani's wide circle of family and friends. I understand that Sani was called upon to provide adventures, sailing lessons, spectacular meals and unwavering support and that she loved every minute.

Last June, the Town of Rockport dedicated their annual town report to Sani Fogel and a female friend said at the time; Sani is a doer. She has strong opinions which are usually right. But at the same time, she's open to what others think. She's always willing to change her mind when someone has a better idea. She has no patience with people sitting around and waiting for others to volunteer. She likes to make things happen.

I think many of us in this Body share that same spirit and we know how much we rely on people like Sani to get the important things in our towns done. Polly Welts Kaufman, of Harpswell. Dr. Kaufman was a historian, educator, naturalist and author of many books and articles, including "National Parks and the Woman's Voice" and "Women Teachers on the Frontier." Her scholarly work focused on the personal experiences and practical achievements of diverse women in American history, and she was a lifelong advocate for the empowerment of all women. She enjoyed a long association with the University of Massachusetts, where she co-created and co-taught the core course for training local women to serve as librarians in the Boston Public Schools and worked with others from 1967 to 1987 to establish more than 100 school libraries. She moved to Harpswell in 1991 and was a visiting professor at Bowdoin College that year and an associate professor at the University of Southern Maine from 1995 to 2014, organizing an original course in the history of the inhabitants of the Casco Bay islands. A Fulbright Scholar, she taught American Studies in Norway from 1999 to 2000 and in 2005. She co-founded the Boston Women's Heritage Trail and worked collaboratively to develop similar trails in Portland and Brunswick, as well as in Norway. She also served on the board of the Pejepscot Historical Society, including as its president during the 1990s. Representative **HEPLER**: Thank you, Madam Speaker, Men and Women of the House. Three things I attribute to Polly Kaufman; one, I'm a better historian because of her. Polly received her PhD at the age of 57. Having received mine at 40, I was tickled to see that someone was crazier than I was. She also continued to create and recreate the courses she taught throughout her teaching career. When I posted her obituary on Facebook this past winter, several younger women I know in the community wrote in to say that they signed up for every course that she taught no matter what the topic. That's a sign of a good teacher.

As a local historian, she taught me and many of us to look at the world around us and to invite public space to be used as a museum. She created, as you heard, the Boston Women's History Trail, eventually four different trails, helped create similar ones in Portland, Brunswick and, I'm proud to say, Farmington. She inspired us to identify buildings and spaces where women worked such as libraries and schools, businesses and industrial buildings to represent where ordinary women held jobs. In the case of Farmington, New England Telephone and Telegraph, for instance, and the corn cannery. Also grave sites of women. We turned these sites into a walkable trail that got us and our students out into the community and reminded us that history is everywhere. I would never have embarked on this project without her enthusiastic and skilled guidance. This is public history at its best and a legacy worthy of this woman.

Two, I'm a better adventurer because of Polly. About 12 years ago, Polly became enamored of Gudrid, an Iceland-born woman who birthed the first European child born in North America. To keep her from undergoing this trip alone, another colleague and I stepped up for a week-long road trip in Iceland.



In truth, we may have used her age to persuade her to let us go with her. We didn't do the ring road around Iceland but, instead, headed overland and down unpopulated peninsulas to find Gudrid's home. I will never forget it. Another time, the three of us headed off to Seneca Falls for a women's history conference. Seeing it through her eyes, a generation older than me whose experiences as a female in what was then a largely male profession was different from mine. She showed me the joy at seeing women's experiences being recognized at long last, something that I had started to take for granted by the time I actually entered the academic world. And as many of her friends and family know, there was the daily swim in the New Meadows River, sometimes year-round.

And third, I'm a better person because of Polly. When I think about her, these are the lessons I will hold; never stop learning, never stop enjoying life, never stop noticing the world around you for new adventures. Her curiosity for intellect, her friendship and her sense of humor will always be with me. She brought people together, a one-woman networking organization. She'd meet someone and say oh, you should meet Candace, she's working on women in business, you study working women, and countless other connections. It's my honor today to share her story with my colleagues in this Chamber. Thank you.

The SPEAKER: The Chair recognizes the Representative from Chelsea, Representative Lemelin.

Representative **LEMELIN**: Thank you, Madam Speaker, and Friends in the House. Seven thousand, two hundred twenty-two years ago, God made them both male and female and He joined them in marriage. To this day, when you are born, the doctor says it's a boy or it's a girl. We do not need legislation in any way, shape, or form with respect to gender identity or sexual orientation. Even though this deceptive bill seems to be cleaning up language, it is doing so to serve evil. There is no such thing as sexual orientation as defined today. Today, it is a made-up term. Therefore, in the name of Jesus Christ, I oppose the pending motion.

The SPEAKER: The Chair recognizes the Representative from Albion, Representative Cyrway.

Representative **CYRWAY**: Thank you, Madam Speaker and Ladies and Gentlemen of the House. I just wanted to speak up about when I had to fill out a form for my bio. It was sent to me from the State House and it had a square and it said gender and it had the letter "U". I don't know what "U" stood for, whether it meant unidentified or unisex or what, but I would think it would be kind of odd, me introducing Madam Speaker and unidentified people of the House. I think that we have to be careful about our unintended consequences and we also have to think about when we put a letter "U" it really messes up, we'll just say, for the census. We depend on grants and federal monies on different gender situations and whatever and so, when we start making it all one gender, I'm thinking that we're really doing some things that we're not really thinking about all the consequences that can happen.

I remember coming to the Chief Executive's first inauguration and we had all-gender restrooms and we had men in the urinals and young girls going into the stalls. That was not an intended consequence, by no means. I asked, actually, the District Attorney if she wanted to go in there and she says I'm not going in there. So, I'm just saying so, this is unintended consequences. And so, we have to be very careful when we do these things and so, I cannot vote on this because of the unintended consequences and I hope that you all think about that before you make these decisions because I think that yeah, we all want everybody treated equally, there's no doubt about that, but I just think that we have to be just careful how we go about doing it. Thank you, Madam Speaker.

The SPEAKER: The Chair is pleased to recognize the Representative from Portland, Representative Moonen.

Representative **MOONEN**: Thank you, Madam Speaker. I haven't even heard anything yet in floor debate that has anything to do with the words in this bill so, I thought I would talk to the words in the bill. There's nothing in here about bathrooms, there's nothing in here about gender markers on documents. This bill is simply a definition fix within the Maine Human Rights Act. Under current law, the term sexual orientation includes gender identity within it and I think there's a recognition now, appropriately so, that gender identity and sexual orientation are not the same thing. As a result of that, previous Legislatures created a separate definition for gender identity that exists within the Maine Human Rights Act. It is now defined on its own terms. Passage of this bill will not change that. Failure to pass this bill will not change that. This bill doesn't change anything except taking gender identity out of the definition of sexual orientation since they are not the same thing. Thank you, Madam Speaker.

The SPEAKER: A roll call has been ordered. The pending question before the House is Acceptance of the Majority Ought to Pass Report. All those in favor will vote yes, those opposed will vote no.
