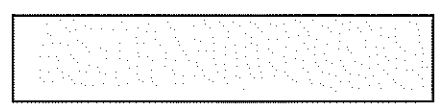

There will be a focus on designing and producing a monthly communication flyer that will feature information that fosters relationships and improves the business process within the Executive Branch of state government. The position will be funded by a transfer from the All Other line category. Funds are no longer needed in the All Other line category for the purpose for which they were originally intended because fewer professional services contracts will be needed than originally budgeted. This position was previously established by financial order ADM00-0059 in fiscal year 2024-25.

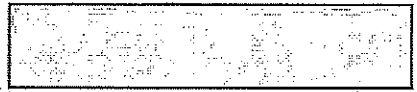

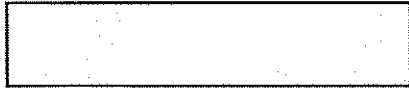

Statement of Fact

This financial order transfers funding from the Statewide - Positions Supporting SFRF Projects, Other Special Revenue Funds account to the Department of Labor Employment Services - Jobs and Recovery Support account to continue 17 limited-period positions through June 6, 2026. These positions were established with funding provided by Public Law 2021, chapter 483 and are designed to expand the department's capacity to assist workers and businesses affected by the COVID-19 pandemic through intensive services to individuals facing employment barriers. The positions were continued with Financial Orders CV0780 F5 and CV0716 F5. Public Law 2023, chapter 643, Part D allocates funding to support positions necessary to complete projects initially funded with funds received through the federal American Rescue Plan Act of 2021 and authorizes the extension of limited-period positions beyond 2 years. Failure to approve this financial order would substantially reduce the department's efforts in meeting Maine Jobs and Recovery Plan goals.

Funds are no longer required in the Labor Client Benefits category and All Other will have sufficient resources to meet obligations for the remainder of the fiscal year.
