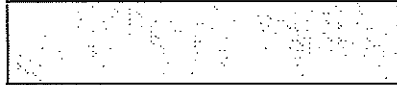


**ORDERED,**

**Statement of Fact**

This financial order will allot a portion of the unencumbered balance forward to fund the purchase of pheasants to stock sites for the 2022 hunting season. This financial order will also correct a first quarter All Other negative allotment balance. Failure to approve this financial order will have a detrimental impact on the department's ability to pay an outstanding invoice for this purchase and also cause the first quarter allotment balance in the All Other line category to remain negative.

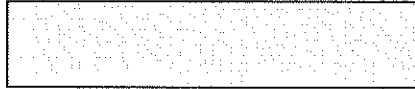

Be it further ordered,  
that the State Controller increase allotment in account 014-02M-0376-01, Board of Licensure in Medicine, by \$5,793 in the Personal Services line category and by \$59 in the All Other line category for the purpose of funding one part-time limited-period Office Assistant I position; and,

that the State Controller authorize the expenditure in accordance with the attached "Revision of the Work Program for Fiscal Year ending June 30, 2023", for which this shall be our sufficient warrant.

**Statement of Fact**

This financial order will establish one part-time limited-period Office Assistant I position in the Board of Licensure in Medicine beginning February 27, 2023 and through June 8, 2024. A portion of the unencumbered balance forward will be used to fund the cost of this position for this fiscal year with the intention of continuing the position by financial order in fiscal year 2023-24. This Office Assistant I position will perform administrative tasks including answering phones, handling mail, and filing licensing and application documents. Failure to establish this position and allot these funds will result in the board not being able to hire this administrative position.
