Hearings will be held on the remainder of departments and programs contained in the Governor's Biennial Budget LR 1852 "An Act Making Unified Appropriations and Allocations for the Expenditures of State Government, General Fund and Other Funds, and Changing Certain Provisions of the Law Necessary to the Proper Operations of State Government for the Fiscal Years Ending June 30, 2016 and June 30, 2017" (the LD number has not yet been assigned).

The documents on this site are the ones that committees will be using for the public hearings. Part A contains all departments and their associated programs (each in alphabetical order) with baseline amounts program initiatives changing appropriations and allocations. Part B (which is not part of the public hearings) contains approved reclassifications and range changes. The Final Document contains the language portions. Part H and Part F as seen on the website are two addendums that provide the appropriations and allocations associated with language parts "H" and "F" but were inadvertently omitted from Part A.
