## §912. Capital and management

- 1. Stock: classes; par value. The capital stock of an industrial bank shall have a par value \$100 for each share, and only one class of such stock shall be created. [PL 1975, c. 500, §1 (NEW).]
- **2. Management.** Except as otherwise provided in this chapter, the management and operations of an industrial bank must be conducted in accordance with the provisions of Title 13-C.
