THE PRESIDENT: The Chair recognizes the Senator from Penobscot, Senator Cathcart.

Senator **CATHCART**: Thank you, Mr. President, men and women of the Senate. I rise to explain my divided report. I have had 12 years of total legislative service and I believe, even though my memory maybe fading as I grow older, that this is the first time that I have every divided a committee report 12 -1. But that's why I want to say a few words to you about the importance of this legislation to me. I'm not going to ask for a division or a roll call. I don't want to put you on the spot. I'm aware that we don't have millions of dollars to help the university system with its increased cost of health insurance. But I did want to point out that they are experiencing an increase of \$14 to \$16 million in one year, which is close to a 50% increase in the health insurance for the 4,500 employees of our university system. This was not a surprise. Last year, former Chancellor MacTaggart had come to Appropriations and asked for extra funding for this situation to help them with the increase. But because money was scarce, we were not able to provide any increase. They worked hard with the Governor and his staff through the fall and I really appreciate the sympathy that the Governor had for this issue. He really wanted to support the university and had hoped, up until December, to put a few million extra into the supplemental budget to help them with the increase. But, alas, once the forecast became real and final, there just did not seem to be any way to do so. So I put in this legislation to make people aware and do a little education about the cost that the University is going to have to come up with. This was because the university system had a 3 year contract at a reasonable price with a company and the company was losing money on it. The insurance company informed them that they would have to give them this huge jump in the rates. We all know that health care and the cost of health care is a huge crisis in our state, not just for our university system but for many small businesses. I met with 4 businesses in my district about the same thing in the days between Christmas and New Years. Why I think it's so important that we consider supporting the university, even if we don't have the money, is that they don't have some of the usual means of raising the money. They have got few choices. They can cut programs and do lay-offs as they did when the legislature cut their funding in the 1990's. They can re-negotiate their contracts. They have 3 year contracts with all of those employees so that they can try to re-negotiate so that the employees pay a higher percentage of their health care costs. We did a comparison in Appropriations of the state employees' plan with the university plan. The university employees do have health insurance that is almost as good as the state employees, but the university employees already pay more than 10% of their cost on their premiums. So that will be difficult to re-negotiate. The other option, and the one that distresses me most of all, is that the university system will have to do what they did in the 1990's when the legislature cut their funding and that is to raise tuition. Tuition is already very high compared to the national tuition rates. We are the lowest in New England but we are high nationally. I can tell you that when the legislature cut the university system in the 1990's, they raised tuition over 50% and the enrollment dropped. Now, in this past fall of 2001, the enrollment in the total university system came back to the level where it was in 1990. We all recognize and know that if we are going to have future prosperity in our state, we need to have a higher educational attainment level; have more people that go onto college. So my concern is that if they have to raise the tuition this time, very high, and we are not able to do something in the near future, in the next few years, we will lose students from enrollment in our university system again, as we did in the 1990's.

Our per-capita income level will drop even further. I hope that today you found your copy of the Executive Summary of the Blue Ribbon Commission on Post Secondary Educational Attainment which I was happy to co-chair. We refer to the need to raise our educational attainment level and to put more money into higher education to do that. I thank you for listening. I just wanted to make that case and tell you why I did something that is unique in my legislative experience and divided a committee report 12 - 1. To me, it was that important. Thank you, Mr. President.

Senator **SHOREY:** Thank you, Mr. President. This bill was before us last session. I'm curious as to why we're seeing it again.

THE PRESIDENT: The Senator from Washington, Senator Shorey poses a question through the Chair to anyone who may wish to answer. The Chair recognizes the Senator from York, Senator McAlevey.

Senator **MCALVEY:** Thank you, Mr. President, men and women of the Senate. I thank the good Senator. That's an excellent question. This is not exactly the same bill we had. This is the stripped down version. What happened is that last week the Attorney General issued a ruling that the previously grandfathered Capitol Security Police had received their duties and were authorized by the trustees of the Criminal Justice Academy, in good faith, years ago. It seems that they didn't have the authority to grandfather them, only we do. Last session, we had a bill that would have remedied the problem. It had a lot of bells and whistles. It passed the other body. Didn't make it through this chamber. What this bill does, it basically grandfathers them until the end of this year, giving us the opportunity to put together a solution that will be a permanent solution. The reality is that last Thursday at mid-night their authority ceased. We need to give them the tools they need to continue their job of protecting us, legitimately and legally. The trustees had acted in good faith. Hopefully we will remedy the problem, temporarily.

This being an Emergency Measure and having received the affirmative vote of 34 Members of the Senate, with no Senators having voted in the negative, and 34 being more than two-thirds of the entire elected Membership of the Senate, was **PASSED TO BE ENACTED** and having been signed by the President, was presented by the Secretary to the Governor for his approval.
