**PASTOR TRACEY:** Thank you for the great privilege of opening today's session with a few remarks and prayer. I had the great privilege of growing up a stones throw away from a stump of volcanic rock known as Slemish. It's in County Antrim in Northern Ireland. It's reputed to be the place where the famous Saint Patrick looked after a herd of pigs when he was a slave. It's a wild looking place, fertile but lonely. As you know very well, Saint Patrick ran away from herding pigs at Slemish. He returned later to Ireland, being burdened for the Irish and their lack of the knowledge of God. Last Saturday, as you know, was Saint Patrick's Day. He was a remarkable man. The Irish are rightly proud of him. He had the courage to chase the snakes out of Ireland. I think he chased them across the Atlantic Ocean. He had the courage to face the high Kings of Ireland, a fierce looking lot. You can't go far in Ireland without coming across numerous places that are named after Patrick himself. Downpatrick, Ardpatrick, Kilpatrick, Templepatrick, and about 80 towns in all of Ireland carry Patrick's name. Maybe some of you have ancestors from those great towns. Royal Irish blood pulsing through your veins, imagine that. There is currently a great interest in Patrick and others like him. Celtic Christianity is what he represents and there is a fascination with Celtic Christianity and what it looked like. It is fascinating because it was pre-reformation Christianity and some feel that this was more authentic. Authenticity is important today. Saint Patrick was an authentic Christian. Perhaps you should Google his prayer called Patrick's Breastplate. This is what Patrick believed. Let me quote just a few sentences.

I arise today  
Through a mighty strength, the invocation of the Trinity,  
Through a belief in the Threeness,  
Through confession of the Oneness  
Of the Creator of creation.

I arise today  
Through the strength of Christ's birth and baptism,  
Through the strength of His crucifixion and burial,  
Through the strength of His resurrection and ascension,  
Through the strength of His descent for the judgment of doom.

Christ with me, Christ before me, Christ behind me,  
Christ in me, Christ beneath me, Christ above me,  
Christ on my right, Christ on my left,  
Christ when I lie down, Christ when I sit down,

Christ in the heart of every man who thinks of me,  
Christ in the mouth of every man who speaks of me,  
Christ in the eye that sees me,  
Christ in the ear that hears me.

That is what Patrick believed. Google Patrick's Breastplate. That is what made a saint out of him. That's what he believed God does, makes saints out of sinners. I think it's worth considering, that Patrick would commend Christ to you and so do I.

Let us pray. Oh Lord, our God, we come before You knowing that You are the great and mighty one. We acknowledge that we are small creatures. We are dust and we return to dust. Help us not to think more highly of ourselves than we ought. We confess that we are prone to be proud. We pray that as authority has been given to the Senators that You will guide them in their work, that they may use their authority as faithful public servants, that they may serve the people. Help them to nurture and protect the weak, the sick, the elderly, and all who are in need. Help them do so with authentic affection and compassion.

We pray that Your hand will protect those who serve in the military and that You will comfort those who even this day mourn for loved ones lost in the line of duty.

We pray that You will be pleased to uphold the cause of justice. Grant wisdom that is necessary to know what is good and what is evil, what is right and what is wrong, and to know the difference between the two. Help us to speak when we must speak; to be silent when we must be silent. Bless each Senator and their families. May they know Your favor and Your grace. Grant to us all humility and grace in Jesus Christ. Amen.

**JOINT RESOLUTION HONORING EDWIN ARLINGTON ROBINSON**

WHEREAS, Edwin Arlington Robinson was born in the village of Head Tide on December 22, 1869 and spent the first 28 years of his life in Gardiner, Maine, which he immortalized in his "Tilbury Town" poems; and

WHEREAS, Edwin Arlington Robinson is recognized as one of the greatest writers in the English language in the first half of the 20th century; and

WHEREAS, Edwin Arlington Robinson was awarded the Pulitzer Prize in 1922 for his "Collected Poems," in 1925 for "The Man Who Died Twice" and in 1928 for "Tristram"; and

WHEREAS, Edwin Arlington Robinson was awarded the degree of Doctor of Literature from Bowdoin College in 1925; and

WHEREAS, Colby College maintains the world's largest collection of the manuscripts of Edwin Arlington Robinson in its library's Special Collections department; and

WHEREAS, the Gardiner Library Association in 2006 created an Internet website entitled "A Virtual Tour of Robinson's Gardiner; Maine"; and

WHEREAS, the United States Department of the Interior, National Part Service has named the Robinson family residence at 67 Lincoln Avenue, Gardiner, Maine a National Historic Landmark in recognition of the literary accomplishments of Edwin Arlington Robinson; and

WHEREAS, Edwin Arlington Robinson's significant contribution to American letters has been recently confirmed by the publication of 3 major books about his life and work: "An Edwin Arlington Robinson Encyclopedia"; "Poems of Edwin Arlington Robinson"; and "Edwin Arlington Robinson: A Poet's Life"; and

WHEREAS, the Patten Free Library in Bath; the Kennebec Historical Society in Augusta; Colby College in Waterville; and the Gardiner Library Association in Gardiner are hosting throughout the first week of April 2007 celebrations in the form of lectures, symposia, walking tours and receptions in honor of the new biography of Edwin Arlington Robinson; now, therefore, be it

RESOLVED: That We, the Members of the One Hundred and Twenty-third Legislature, now assembled in the First Regular Session, on behalf of the people we represent, take this opportunity to honor this fine Maine poet and declare the first week of April 2007 Edwin Arlington Robinson Week in Maine; and be it further

**JOINT RESOLUTION TO RECOGNIZE MANUFACTURING IN MAINE ON MARCH 21, 2007**

WHEREAS, manufacturing employs 58,000 of Maine's citizens, 12% of Maine's private sector work force; and

WHEREAS, manufacturing is the 3rd largest sector of Maine's gross domestic product, ranking behind only government and real estate; and

WHEREAS, Maine's manufacturing output continues to grow at a steady pace, rising 6-fold between 1947 and 2005; and

WHEREAS, Maine has a long history in manufacturing, including one of the first paper mills in North America; and

WHEREAS, manufacturing served as a magnet, drawing a rich diversity of cultures that form a social fabric of the fine qualities of Maine people; and

WHEREAS, manufacturing has the highest multiplier effect of any sector of Maine's economy, generating over \$6 billion of economic activity in other sectors of the economy; and

WHEREAS, Maine's manufacturing workers earn an average of \$42,000 per year, with generous health care and other benefits; and

WHEREAS, Maine's paper industry alone, just one part of Maine's manufacturing community, pays more than \$500 million in direct wages to its employees; and

WHEREAS, 67% of workers engaged in goods production jobs in Maine are located in rural areas of the State, and manufacturing jobs are critical to maintaining the economic vitality of rural communities; and

WHEREAS, thousands of jobs in the manufacturing industry in Maine are expected to become available in the next 10 years through job growth and the aging workforce; and

WHEREAS, manufacturing productivity consistently outpaces productivity growth in other areas, and Maine's economic health is tied to the viability and competitiveness of Maine's manufacturers; and

WHEREAS, Maine manufacturers are facing increasing competition from global markets, and it is in the best interests of the State to promote and encourage the health and competitiveness of Maine manufacturers; now, therefore, be it

RESOLVED: That We, the Members of the One Hundred and Twenty-third Legislature, now assembled in the First Regular Session, on behalf of the people we represent, take this opportunity to express our support for the manufacturing industry in Maine and to recognize the contributions of Maine manufacturers and their employees on March 21, 2007 at the State House.

WHEREAS, Philip of Macedonia, his son Alexander the Great  
and Alexander's tutor, the noted philosopher Aristotle, were born  
and raised in the northern province of Greece, Macedonia, and  
the language and culture of the ancient Macedonians and the

WHEREAS, the Founding Fathers of the United States of
