JOINT RESOLUTION RECOGNIZING ROBERT L. WOODBURY, THE LATE CHANCELLOR OF THE UNIVERSITY OF MAINE SYSTEM

WHEREAS, Robert L. Woodbury, of Falmouth, passed away from lymphoma in September 2009 at the age of 71 after living a vital and energetic life of commitment to other people and to the field of education, not only in Maine but in the international arena as well; and

WHEREAS, Chancellor Woodbury graduated from Belmont Hill School in 1956 and from Amherst College in 1960, and he earned a doctorate in American Studies from Yale University in 1966, beginning his career as a professor at the California Institute of Technology before becoming a senior administrator at the University of Massachusetts at Amherst; and

WHEREAS, Chancellor Woodbury came to Maine with his family to serve as the President of the University of Southern Maine in 1979, a time of great growth and expansion for the former University of Maine at Portland-Gorham, and he led the university after the merger of the Portland and Gorham schools and helped establish the Edmund Muskie Institute of Public Affairs; and

WHEREAS, the University of Southern Maine community honored Chancellor Woodbury's excellent service by naming the building that contained the student center, a cafeteria and the university bookstore on the expanding Portland campus the Robert L. Woodbury Campus Center; and

WHEREAS, Chancellor Woodbury went on to serve as Chancellor of the University of Maine System, overseeing the State's 7 university campuses from 1986 to 1993, and he ran for Governor of the State of Maine, hoping he could continue to serve the people of Maine; and

WHEREAS, Chancellor Woodbury served on a multitude of educational boards, including serving as chair of the board of the Council on International Educational Exchange, and remained an educator even in retirement, helping to found American University in Bulgaria and working to develop city-to-city exchanges between the United States and South Africa just before he died; and

WHEREAS, Chancellor Woodbury was devoted to his wife and his family, a major source of pride for him, and he was happy to have all of his children and their families living nearby in Maine throughout his retirement; now, therefore, be it

RESOLVED: That We, the Members of the One Hundred and Twenty-fourth Legislature now assembled in the Second Regular Session, on behalf of the people we represent, take this opportunity to honor the memory of Robert L. Woodbury and his commitment, dedication and work for the people of the State of Maine.

THE PRESIDENT: The Chair recognizes the Senator from Penobscot, Senator Schneider.

Senator **SCHNEIDER:** Thank you, Madame President. Men and women of the Senate, I am very happy to stand and join with my colleagues in presenting this Joint Resolution recognizing Robert Woodbury's lifetime of service. He was a committed family man and I'm glad to say that his family is here with us in his memory. A lifelong educator and a tremendous public servant. It's interesting that I grew up very close, during the summers, to the Woodbury family in Christmas Cove. We all have something very much in common, which is our love for this state. Robert Woodbury is a beloved member of the education community. He had an intense ability to reach out to people and make them understand the importance of higher education. After attending college at Amherst and graduated of Yale University, Robert took a position as professor of the California Institute of Technology. He then took a senior administrator position at the University of Massachusetts at Amherst. Robert began working in Maine in 1979 as President of the University of Southern Maine. As President, he worked to help establish the Edmund Muskie Institute for Public Affairs. In 1986 he was named as Chancellor of the University of Maine System and held that position until 1993. While Chancellor, Robert led the University System through many challenges, demonstrating his superb leadership skills and capabilities. Robert increased the level of enrollment and improved the accessibility of the college and enhanced the quality of education students in the University of Maine System receive. He is, and always will be, a great asset to this state because his work continues on. He is sorely missed by all of us and I want to thank his family and him for his lifetime of service. We are very fortunate to have had him as a devoted servant to the State of Maine. Thank you.

THE PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Bliss.

Senator **BLISS:** Thank you, Madame President. Ladies and gentlemen of the Senate, I suspect that most of you know that I've spent my career working in higher education. I spent 20 years working at the University of Southern Maine, although I came to that institution right after Bob Woodbury left to become Chancellor. I've had the occasion to interact with Bob over the years and I want to talk about something that, in my mind, differentiates him from virtually every other University administrator with whom students have the opportunity to come in contact. College presidents, and certainly chancellors, often deserve the description of living in an ivory tower, of separating themselves from their institutions and their students because they're too busy looking at the big picture. Bob is maybe the opposite of that. If you walked into a room of administrators at the University, either at the Chancellor's office or on the campus of the University of Southern Maine, Bob would always be the first person to have a giant smile and stick out his hand to introduce himself to you. He was the friendliest administrator I ever met, the most knowledgeable administrator I ever met, and the administrator who was most inclined to sit and listen to students and pay attention to what they thought about what was going on. You cannot have a better administrator than that. I too am glad that the Woodbury family is here. I thought Bob was terrific. I still have my Woodbury for Governor sign in my basement, and I'm

delighted that we're taking the time to honor Bob and his family. Thank you, Madame President.

THE PRESIDENT: The Chair recognizes the Senator from Penobscot, Senator Perry.

Senator **PERRY:** Thank you, Madame President. Ladies and gentlemen of the Senate, I knew Bob Woodbury well. Not in the way I may know any of you well, because I only met him once, and only for just a minute right here in this building, down in the Taxation Committee office. He was here for a meeting and afterwards dropped by to see his son, Richard Woodbury, who I shared that office with and who I consider a dear friend. When he left, I could just sense something, and I said to Dick afterwards, 'Boy there's something about your dad, he's so engaging and likeable, and I was really pleased I had the opportunity to meet him.' That's how I knew him, through his son, Dick. Whenever we'd talk about his dad, I could always see what was clear to me as the pride, admiration and affection that always came through. It's clear in the family that he and his wife Anne raised what kind of man he was. He's clearly left a legacy that will last for generations. To the Woodburys who are here today, I know how sorely he's missed and I'm sorry for your loss.

The Federal change said that if anyone contributed money to the Haiti relief effort this year they could deduct it retroactively off last year's taxes. That's simply what this amendment does. It allows donations given this year to be a deduction on last year's taxes. Both pieces are taxpayer friendly and ought to be non-controversial. Thank you.

Senator **BLISS:** Thank you, Madame President. Men and women of the Senate, when this Committee Amendment was put together in the Transportation Committee, after a great deal of discussion and hard work, a fairly innocent phrase was inserted that didn't seem to mean much to Committee members or to a budding young attorney on the Committee. The phrase was, 'a reasonable articulable suspicion.' That phrase has a particular meaning to law enforcement officials and in the view of the law enforcement community, the addition of this phrase in the bill raises the bar and prevents them from using this new technology to its full capabilities for community service types of work. There has been a great deal of discussion on the part of the South Portland police department, the Maine Civil Liberties Union, and the Commissioner of Public Safety, who all worked very hard to find a substitute phrase that would both allow the police the flexibility to use this technology for community service work, while

at the same time protecting the rights of individual citizens. The phrase that they came up with, which is substantially longer than 'reasonable articulable suspicion' is 'specific and articulable facts of a concern for safety, wrongdoing or a criminal investigation or pursuant to a civil order.' That is the sum total of this amendment. It is an effort to ensure that the bill goes forward based upon the Committee's amendment, but changes that phrase to allow both the police to take full advantage of the technology for community service types of work and also protects the individual freedoms and protects individual citizens, which is what the Civil Liberties Union requested. So I urge you to adopt this amendment. Thank you, Madame President.

With our digital technology, should an officer make a traffic stop and ask for the documentation that they always ask for, at least I've heard they ask for - I've never really had it happen since last Monday, and when they call that in, all of that information becomes available to them. It is deemed not necessary to have that label attached or affixed to the physical license. This amendment will remove that requirement. Thank you, Madame President.

ROLL CALL (#335)

Senator **MILLS**: Thank you, Madame President. Men and women of the Senate, I rise briefly to urge the Body to oppose the pending motion. The bill, as it finally came up from the Human Services Committee, does a couple of things that I think are unnecessary. It requires PBMs to register with the Bureau of Insurance. They are not themselves insurers. They are entities that contract typically with insurers or with very large self-insured employers. When I pose questions about why we were asking them to register with the Bureau of Insurance, I have, quite candidly, got no good answer. I don't know who we're trying to protect. I just couldn't fathom what the reasons were for imposing a registration requirement on these businesses. They are large and sophisticated entities that do business with other very large and sophisticated entities, typically insurers and large employers. I couldn't understand why we would have these contracts the subject of registration at the Bureau.

The other part of this bill asks that the State Auditor audit State contracts in which PBM services are purchased. Here again, if there are public contracts with PBMs, these are arrangements that are entered into by some of the more highly sophisticated purchasers of health care services in our state. I don't understand what value the State Auditor can add to monitoring those relationships. For that reason, and just in the interest of not adding more unnecessary laws to our books, I am urging the Body to vote no on the pending motion. Thank you.

THE PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Brannigan.

Senator **BRANNIGAN**: Thank you, Madame President. Men and women of the Senate, I do believe that this is an important piece of legislation. These groups are huge and they're major players between insurance situations and the drug companies. We have laws by which they have to share with us certain rebates that they get. They have been derelict in their duties and they've been found so by the courts. Other states have found that they have to have some way of encouraging them to do what they're supposed to do. That's why we're saying that they need to be licensed, so our Bureau of Insurance and our very tough Commissioner will be able to direct them in the way they should go. I like what one of the courts said about them when they've had to be taken to court, we don't want to continue to do that, but they said that they produce a layer of fog between the pharmaceutical companies, and we know about them, and the State insurance people, Anthem, all of them. They all have this group and we need to have some ability to allow them to do things the way they should. Thank you very much.

THE PRESIDENT: The pending question before the Senate is the motion by the Senator from Cumberland, Senator Brannigan to Accept the Majority Ought to Pass as Amended Report. A Roll Call has been ordered. Is the Senate ready for the question?

Senator **MARRACHÉ:** Thank you, Madame President. Men and women of the Senate, I just wanted to update everybody on what this bill does. It was an enormous bill, omnibus so to say, and we gutted out of it almost everything that was there that was onerous. We took out the rabies part and the transportation of infected animals part. There was a 25% increase in fees that were going to be applied to municipalities for records and things that the vital records department was doing for them. We had a long few days dealing with this and we got that removed. What we did is we removed the rabies, removed the transportation, and the burial permit fees were reduced to \$20 instead of what it was before, I believe \$40. It was an arrangement made between municipalities, the clerk's office, and vital records that the 35% payback would be removed. The vital records department could not function without any money so they will continue to do the job they ask of them but they are going to have to pay for the paper and the toner and for the supplies that they need to have them print these documents off for them. The clerks all agreed. That was the agreement that was made and this is the bill in its entirety, which has all compromises. Thank you.
