**JOINT RESOLUTION MEMORIALIZING THE PRESIDENT OF THE UNITED STATES, THE UNITED STATES CONGRESS AND THE UNITED STATES SECRETARY OF EDUCATION TO OPPOSE THE MOVE TOWARD COMPETITIVE GRANTS IN THE DISTRIBUTION OF FEDERAL EDUCATION AID**

WE, your Memorialists, the Members of the One Hundred and Twenty-fifth Legislature of the State of Maine now assembled in the First Regular Session, most respectfully present and petition the President of the United States, the United States Congress and the Secretary of Education as follows:

WHEREAS, the administration of President Barack H. Obama has made it known that it wants to rely more on the use of competitive grants to award federal education aid to states, and it is likely to incorporate competitive grants in its proposal to reauthorize the Elementary and Secondary Education Act, known as the No Child Left Behind Act; and

WHEREAS, the shift to competitive grants as opposed to formula allocations will hurt rural states like Maine that lack the people or the capacity at the state and local levels to devote to the grant-writing process; and

WHEREAS, Maine currently receives an estimated \$200,000,000 in federal money annually, distributed largely through formula allocations, that supports programs for the State's neediest children; and

WHEREAS, changing federal aid to a competitive grant system would jeopardize that funding at a time when the State needs it most, in these serious economic times, and it would hurt the education of children who need it most; and

WHEREAS, the Maine School Boards Association and the Maine School Superintendents Association, which represent school districts across the State, have formally adopted positions opposed to this move toward competitive grants, now, therefore, be it

RESOLVED: That We, your Memorialists, respectfully urge and request the President and Congress of the United States and the United States Secretary of Education to continue to rely on formula allocations that recognize the obligation to educate all our children regardless of where they live and reject the move toward distributing federal education aid through competitive grants; and be it further

RESOLVED: That suitable copies of this resolution, duly authenticated by the Secretary of State, be transmitted to the Honorable Barack H. Obama, President of the United States, to the President of the United States Senate, to the Speaker of the United States House of Representatives, the Honorable Arne Duncan, Secretary of Education, and to each Member of the Maine Congressional Delegation.

**THE PRESIDENT:** The Chair recognizes the Senator from Oxford, Senator Patrick.

Senator **PATRICK:** Thank you Mr. President. Ladies and gentlemen of the Senate, colleagues and friends, I rise in opposition to this bill, which is "An Act to Allow Farm Wineries to Charge for Wine Tastings". I have, over the last ten years, been against these bills for a lot of reasons, but primarily because what this bill is is yet another carve out to the three-tiered system. Many of you probably haven't got a clue on what the three-tiered system is, but I will, basically, try to explain. Right now current law permits farm wineries to offer complimentary wine for tastings at winery locations. The wine may be offered during the regular business hours for the winery but only after noon on Sundays. This bill proposes to permit farm wineries to charge for these samples. Maine alcoholic beverage laws established a clear division between retailers licensed to sell alcohol to be consumed on the premises and those who sell alcohol to be consumed off the premises. Any laws that permit crossing that division are to be narrowly crafted. Tastings are an exception on the law that prohibits the consumption of alcoholic beverages on an off premise retailer. Other exceptions that go to the division are the recently enacted dual liquor license and growler. Growlers are containers, typically a one half gallon or gallon size, of beer poured from the tap at a brew pub or brewers on premises establishment. Farm wineries are eligible to also have an on premises establishment as an exception to the three-tiered system, where they could charge for wine and other beverages served. The policy question is, "What is the purpose of tastings?" Historically tastings have been represented as a means to promote the product sold by an off premises licensee. They have been, as required by law, free and open to the public. Does this purpose still hold true today or has it changed? How should this be viewed in terms of other entities that conduct tastings, which are beer and spirits? I think this is actually somewhat discriminatory because we haven't been inclusive of all three. If we're going to let it rip and allow tastings for everything we ought to allow tastings for spirits and beer and let them charge for the samples as well.

What is the three-tiered system? The three-tiered system is a system that was enacted years ago after prohibition. With the repeal of prohibition, states looking for a policy of regulating sales of alcoholic beverages enacted the three-tiered system. This policy was intended to curb the negative social impact in terms of public health and safety caused by alcohol abuse and to prevent a few large manufacturers from controlling the marketplace, limiting consumer choice and exerting too much influence. The

three tiers create a barrier between the manufacturer and the retailer. The middle tier is a distributor. The purpose of the distributive tier is to separate the manufacturer from the retailer based on the assumption that the manufacturer's interest in selling the product far outweighs concerns about the negative impacts that alcohol abuse has on the health and safety of the public. The system prohibits control, influence, ownership, and operation by one tier or any other part of another. We have numerous exemptions to the three-tiered system and sooner or later, if you continue to keep carving out the three-tiered system, it's going to be totally abolished. One of the things that I will say, if you know anything about the distributors and the manufacturers, there are thousands of jobs in the state of Maine that pay livable wages with benefits, which seems to be an oddity in this day and age. I want to protect those jobs and those benefits for those employees. Exemptions to the three-tiered system include Maine farm wineries, small breweries, and small brewery distilleries. The licensee produces less than 50,000 gallons per year, or distillers produce less than 30,000 gallons per year. They may sell directly to the winery or brewery or to retail licenses and may hold a license to sell liquor for non-premise consumption. Recently enacted provisions allow the sale of wine by mail by authorized licensees.

I'm really not against small business, although it may sound like I am. I just want to protect the system that we have in place and if we're going to allow the publicity for a person's product, which happens everywhere and most of the time it's for free, allowing them to charge for their product, I think, although it is another way of them getting a little bit more profit which I am really am not too bad against. What I'd like to see happen is to make their product and selling millions and millions of gallons from Maine farm wineries throughout the country and throughout the world. I think that is the best part of it. I'm not sure what we really gain out of this other than a few more dollars to the individual, but one of the things you will find, and probably no one cares about anymore, is the damage three-tiered system. I've always been a staunch supporter of it and I will continue to do so. I would ask you to follow my light. Thank you very much.

**THE PRESIDENT:** The Chair recognizes the Senator from Hancock, Senator Langley.

Senator **LANGLEY:** Thank you Mr. President. Men and women of the Senate, I find myself in agreement of quite a bit of what the good Senator says about the desire to keep and help our small businesses stay open. Please realize that these small farm wineries are exactly that, small businesses who are looking for an option. This is not a mandate that they charge. These folks will have to consider very heavily whether charging for a product that they had given away for free in these tastings is actually going to help their businesses. When I was out knocking door-to-door I ended up down in Winter Harbor at the Bartlett Farm Estate Winery. They said this is one thing that we could do here in this legislature that would help them keep their doors open. Simply put, as people come through as part of their tourism travels to Downeast Maine they often put the winery on that as a stop. Very often it is just that a tourist stops, has some samples, and continues on their way to Skootic Park and Arcadia National Park. This would just allow them to cover the cost of giving those samples away. It would not, indeed, completely cover the cost.

The Bartletts, in my conversation, were one of the first farm wineries to open up in the state in the 1980's. They, in fact, have

gotten to the point where they had hired employees and now, because of the downturn in the economy, are down to just Mr. and Mrs. Bartlett. You can picture in your mind that they are practically squeezing the grapes all the way through to processing and bottling and then putting it out to sale. This is, indeed, an option they will have to weigh very heavily. They won't do that lightly. This would be just another tool that they could use to keep their doors open. I would ask you to support this bill. Thank you very much.

**THE PRESIDENT:** The Chair recognizes the Senator from Oxford, Senator Patrick.

Senator **PATRICK:** Thank you Mr. President. Ladies and gentlemen of the Senate, colleagues and friends, I rise a second time to reflect on some of the testimony that was given at the committee on this issue. The problem with the carve outs in the three-tiered system are such that sooner or later, like I said, we're going to have to disband the whole system and do things that are totally different and that we may not want. Some of the testimony at the committee on this bill and similar bills was on what actually the small wineries want. We gave them the opportunity to come into fruition as a small winery. We gave them the ability to have wine tastings. I asked one or two of the people, "What's next? What else do you want? Do you want to sell wine at farmer's markets? Do you want to have taste testing at farmer's markets? Do you want to charge for taste testing at farmer's markets?" What is next? Are they going to ask to go to sporting events? Are they going to ask to go to churches and have wine tasting and have you pay for them at the church? At sporting events, at high school events? I'm not sure, but somewhere, somehow we've got to have a little commonsense and a little control. I would ask you to vote against this bill. Thank you, Mr. President.

**THE PRESIDENT:** The Chair recognizes the Senator from Hancock, Senator Langley.

Senator **LANGLEY:** Thank you Mr. President. Men and women of the Senate, I can answer that question. These folks would just like to survive and keep their doors open. Thank you.

At the request of Senator **COURTNEY** of York, Report **READ**.

**THE PRESIDENT:** The Chair recognizes the Senator from Oxford, Senator Patrick.

Senator **PATRICK:** Thank you Mr. President. Ladies and gentlemen of the Senate, colleagues and friends, I really respect the vote taken in the committee with the roll call. The majority, yes, they had the foresight to try to pass this bill. The one thing I will say as being on that committee for nine years, learning and understanding the three-tiered system and the ramifications of what happens and what is going to happen in the future, I can honestly say there is very little knowledge left on the committee on these issues. I respect each and every one's vote but would still ask you to vote Ought Not to Pass.

**THE PRESIDENT:** The Chair recognizes the Senator from Penobscot, Senator Plowman.

Senator **PLOWMAN:** Thank you Mr. President. Men and women of the Senate, I have served seven years on the committee and I understand the three-tiered process. I am on the other side of this bill. This is actually an arrow in the quiver of a small farm winery which they may or may not choose, as part of their business plan, to charge a small amount for product that is consumed on their property. In my estimation, it would be something that you would only very carefully consider because once you make the decision you cannot very quickly undo it. We have so few small farm wineries that it's not going to be a huge change in the system and, frankly, it's right on their own property at this point. No one has said that this is expanding to, God forbid, church. With all due respect, I think this is probably the smallest change we've ever made to the three-tiered system. The report, whether a great majority or not, I do believe there is some understanding on the committee and I would beg to say that my seven years should count somewhat. Thank you.

**THE PRESIDENT:** The Chair recognizes the Senator from Lincoln, Senator Trahan.

Senator **TRAHAN:** Thank you Mr. President. May I pose a question through the Chair?

**THE PRESIDENT:** The Senator may pose his question.

Senator **TRAHAN:** Thank you Mr. President. To anyone who can answer this question, I've been to wine tastings and usually the way the process works is that you go through a line, you taste wines, and then, based on what you happened to have a personal taste for, you then purchase the wine. Can you explain to me why it's okay to purchase the wine, literally seconds or moments from when you just tasted it, can you explain to me what the difference is?

**THE PRESIDENT:** The Senator from Lincoln, Senator Trahan poses a question through the Chair to anyone who may wish to answer. The pending question before the Senate is the motion by the Senator from York, Senator Courtney to Pass to be Engrossed as Amended by Committee Amendment "A" (S-25). A Roll Call has been ordered. Is the Senate ready for the question?
