Experience shows that students that spend time training in our great state are more likely to stay in Maine for residency, or return to Maine after their residency program, and eventually practice here. So I'm so pleased that so many students from the MMC Tufts Program are with us here today. Many are from your own communities and I am hoping that many, many of these students continue to stay in Maine, practice where we dearly need you. Thank you.

**THE PRESIDENT:** The Chair recognizes the Senator from Cumberland, Senator Millett.

Senator **MILLETT:** Thank you, Mr. President. Mr. President, ladies and gentlemen of the Senate, I just want to take a moment to acknowledge where we are and how far we've come. L.D. 369, in its amended form, is the truest form of compromise. By passing L.D. 369, we will ensure that workers across the state can earn time off from work to use when they need it the most without the fear of losing a paycheck or jeopardizing their job. It sounds simple and it should be, but right now 40% of Maine workers don't have access to earned paid time off. Today we can help to set things right. We have worked to address the concerns raised by leaders in our business community. We have established an easy to implement system that is free from red tape. With this compromise, we are able to ensure that 85% of all Maine workers are covered by this earned time off policy. It also exempts more than 40,000 of our 50,792 businesses in Maine, allowing them to implement policies that work best for them and their employees. I am proud of the work undertaken to get lawmakers on both sides of the aisle onboard. This process tells us one thing, when legislators reach across the aisle and work together we can create good, common sense policy. This bill, at its core, is about economic fairness. If childcare is canceled parents should be able to stay home to take care of their children without fearing economic consequence. If a worker's car breaks down on the way to work they should be able to take it to the shop without fearing that they lose the paycheck to pay for the repair. If a worker is sick they shouldn't have to choose between visiting the doctor or keeping their job. If an aging parent falls on the ice and needs a ride to the hospital no adult should feel like they cannot be there. I would like to thank Governor Janet Mills for her support and the guarantee that her administration will implement and enforce this law fully and fairly. The Department of Labor will be there for Maine workers, ensuring that they aren't punished by employers for exercising their rights, and is committed to working with businesses to make this law as easy to implement as possible. I'd also like to thank the Labor and Housing Committee, under the leadership of Senator Bellows and Senator Guerin, for the hard work and long hours they invested in reaching the strong, bipartisan compromise. Thank you for your consideration of L.D. 369, enshrining basic rights for hard working Maine people. Thank you, Mr. President.

**THE PRESIDENT:** The Chair recognizes the Senator from Kennebec, Senator Bellows.

Senator **BELLOWS:** Thank you, Mr. President. I rise in support of the pending motion and first would like to extend my deepest gratitude and admiration for my good colleague from Cumberland, Senator Millett, for her historic and determined persistence and

compromise. This bill is a culmination of multiple years of effort of work, and I do that on behalf of one constituent who reached out to me on social media. She's been working for over a decade at the same employer without a paid day off. For her, a mother of a child in high school and the daughter of aging parents, this bill means everything. I fully support the pending measure as a critical measure for the people of Maine to ensure that all workers in the state will have access to paid time off they can use to address health needs and care for their families. The law will give workers paid time off and, because it is guaranteed by law, those workers can be secure, knowing they cannot be retaliated against for using this time. I'm proud to support this measure which will ensure that Maine workers can take this time off without fear of retaliation or job loss for taking that time. We, in the Senate, applaud the Chief Executive for her recognition of the importance of paid time off for workers and are confident that she, and the excellent personnel of the Department of Labor, will ensure robust enforcement of the law so that Maine workers need not fear retaliation for taking the time off that this law gives them. We are excited, I am excited, to support a law that will entitle Maine workers to this time off, meaning they can take the time without suffering economic hardship, without fearing that they might be fired or hurt at work. I have so much confidence in the Department of Labor in enforcing this law. I think that this is a truly momentous and historic step forward for our state. Thank you.
