Senate called to order by President Troy D. Jackson of Aroostook County.

Prayer by Pastor Clint Compton, Kennebec Valley Assembly of God in Chelsea.

**PASTOR COMPTON:** Good morning. I was asked when I pray not to get political and to be respectful of other people's religious beliefs, so that's what I'm going to endeavor to do, except I might just say this, that politics, as you all are much more aware than I am, involves morality. You make laws, don't you? Laws that you expect to be obeyed. Laws that are obeyed have moral implications to them. In the request, it's a non-sectarian prayer which, I assume, means that a religious prayer of some sort. I've got to say, I became a Christian at 29 years of age. I've lived a rough life and one God that I know of changed my life. Took me out of drugs. Took me out of alcohol. Took me out of a dysfunctional relationships and completely transformed my life, in a long process and not an overnight situation. So I just want to say that I'm thankful to be here. It's awkward for me to be here. It's the third time I've been here but it's still very awkward to be in this place. You guys are going to have a busy year this year and there's been a lot of significant legislation that's been passed and you still have more to go from what I understand. So my prayer is for you. My prayer is that the will of God be done in this place, and that's what I'm going to pray in just a moment and not going to get radical and weird on you, so don't worry about that. But I do pray to just one God and I acknowledge that God, and Him only, and his son, Jesus Christ, as well as the power of the Holy Spirit. So let me pray, and I will be, I really want to be sensitive to the differences in this room, but I also want to be sensitive to the reality that there is a God and the decisions that we make effect people and you effect the people that you represent, that you effect also the children of this state. You affect the finances of this state. You play a very significant part of what goes on in this state. I just want us all to realize there is a God who is aware of the things that you're doing. It's to Him that we give account and give account we will. So issues like abortion, suicide; those are huge, heavy decisions and I suggest to you that God, Himself, has an opinion on that. It would be a good thing to find out what God's ideas are in regards to that is. I'm going to pray a prayer out of Matthew chapter 6, starting with verse 9. I would imagine, looking around this room, that all of you are familiar with this particular prayer because it's called the Lord's Prayer and I remember as a little boy praying this prayer and we mastered it in about 10 seconds. I don't think that that was the foundation that Jesus had, in that moment of giving this prayer when he was asked to teach us to pray. I really think what he was doing was giving the foundation, not just something to be replicated and repeated as fast as possible. But as little boys we didn't know any better. As adults we come to a deeper understanding. So I

just trust at this moment that God in His sovereignty, God in His mercy, as well as in His love and forgiveness, that He would just move in this moment in each of our lives and that maybe this prayer would have an effect. The prayer starts out like this: 'Our Father, in Heaven, hallowed be your name.' I just want to say, God, that You're in heaven, that doesn't mean You're not here. There's a scripture that says wherever two or three are gathered in my name there am I in the midst. So You're right here. We haven't forgotten, Jesus. So when you've given this word, we hallow Your name and You've given some places in the word of God about Your name. You said, 'My name is righteous.' You said, 'My name is holy.' You said, 'My name is provider,' and that's what you do, God. You do provide. We live in America. We've been given some of the greatest provisions in all the world that we could imagine. We thank You for that. You said that You are peace, that You are the God of peace. Lord, thank You that through Jesus there is peace that reigns in our heart through the many, many struggles and many, many difficult decisions and many things that are met with representing adversity in our life. It's a part of defining who you are. We thank You for Your power, Lord. So we say, 'Hallowed be thy name,' and we pray, God, to You that Your kingdom would come and that Your will would be done on earth as it is in heaven, just as things are in heaven, Lord. Some day the kingdom comes on its fullness and, Lord, we pray that even now, in this room at this moment, a part of that fullness would be released at this time, that there would be order, that there would be love, there would be forgiveness, there would be deliverance, there would be freedom, there would be healing as You promised there would be. So, Lord, we ask that Your kingdom come, the dominion of God, not the dominion just of the state of Maine or anyone else, Lord, but the dominion of the Creator, himself, eternal. That He would visit this room in this moment and every single life, because that's what Your desire is, God, and that Your will would be done, God, in this moment. It's a good will. It's a holy will. There's even a place that You say that You're not willing that any should perish but that all would come to eternal life. So, Lord, we pray the will of You be done on earth as it is in heaven. That You would give us this day our daily bread. Father, we need sustenance. We need provision. These folks are a part, right here in this room right now, of providing those things to us. Lord, may it come and may it be recognized that it comes from Your hand and Your abundance. The blessings that You place upon our life. Lord, provision the bread. Ultimately, Lord, the understanding of bread is sustenance, it's provision. The great sustenance I know to man is Jesus Christ who declared himself, 'I am the bread of life. Anyone who would eat of me would have eternal life.' So, Lord, we look to You. Forgive us our sins, Lord, as we forgive those who have sinned against us. Boy, there's a lot of controversy, God, about sin today. There's a lot of controversy about political opinions and a lot of war that goes on and a lot of animosities develop. Lord, what we pray is that right now an explosion of Your presence and Your power and Your goodness and Your mercy, Your love, Your peace would visit every one of our lives in a special and powerful, unique way. That it would reveal to us, Lord, the true author, the protector of our lives. Forgive us our sins, Lord. We make decisions many times out of greed, out of pride, out of arrogance, out of self-serving, out of a desire for our own personal comfort, and we're so thankful that Jesus didn't come to make himself comfortable. He came to give us life and give it to us more abundantly. So, Lord, we thank You. We learn to forgive others, God, because we've perpetrated enough against You, as well as

others. God, we forgive others. We let them go right now. Lead us not into temptation, Lord, but deliver us from evil. There is a temptation, God, to do things my way. There's a temptation just to trust in my own knowledge when You've got a bible there, Lord, that can explain to us all the ways of life. So, Lord, the temptation to trust me or to trust You, I pray that there would be something of Your spirit that would move this place, that would say I know what You would have to say about things, God, and I don't want to be led by evil. I want to be led by truth. I want to be led by righteousness. So I ask all that. Bless these folks today, God. May they make laws and may they search out things on committees and may they make decisions based on the will of You, God. In Jesus' mighty name. Amen.

Senator **VITELLI:** Thank you, Mr. President. I want to speak in strong support of L.D. 995, An Act to Establish a Student Loan Bill of Rights to License and Regulate Student Loan Services. This is an issue that I've been working on for several years. You have a fact sheet on your desk that I would point out to you for further information. I would say that student loan borrowers across Maine and the country who are actively trying to pay-down their

school debt are being blocked, misled, and manipulated, or flat out lied to, by their loan servicers and that this is unacceptable. These companies are engaging in practices we would never tolerate from mortgage lenders, credit card companies, or banks. College graduates in Maine owe more than \$6 billion in loans. That's "B" with billion. One in five Mainers carry student debt. This student debt burden has led to fewer young people buying homes, starting a family, and saving for retirement. This crisis affects seniors too. In 2017, an estimated 21,000 Maine seniors, those are people my age, had student loan debt, an increase of 46% from 2012. Older adults still paying off loans they took out for themselves or their children are eating into the retirement savings and jeopardizing their future. Unlike other debt, student loans cannot be discharged. Social Security payments can be garnered to pay for these debts. The predatory practices of student loan services exacerbate the economic crisis this causes. Federal and private student loan borrowers of all ages report difficulty getting the information they need in an accurate, timely, and honest way to enable them to responsibly repay their loans and satisfy their obligations. Student loan services are largely unregulated. That means they get away with a wide variety of shocking, unethical practices, including lying about what programs public service workers qualify for, selling or buying other loans without telling borrowers how to access their accounts or even make payments, and steering borrowers towards forbearance when they're seeking income-based repayment options. It is clear to me that Maine needs to make sure that these companies have proper oversight to help protect our borrowers. L.D. 995 provides that oversight. It gives Mainers a place to get help when they need it and provides a mechanism to hold loan servicers accountable. I hope my colleagues will all see fit to provide overdue oversight to student loan servicers. Please follow my light in voting to pass L.D. 995. Thank you.

**THE PRESIDENT:** The Chair recognizes the Senator from York, Senator Foley.

Senator **FOLEY:** Thank you, Mr. President. Ladies and gentlemen of the Senate, I rise in opposition to the pending motion. This original bill was a solution to a problem that was created by the Maine Supreme Court decision that rock seaweed attached to rocks on private property is the right of the property owner. Initially, I would not say that it's the purview of the Legislature to override a Supreme Court decision but the bill went a lot further than work session and it extended rights up and down the Maine coastline in the tidal zone. I was a Selectman in the town of Wells when the first case on intertidal land ownership was decided in Bell vs. Wells, the Moody Beach case, where the Supreme Judicial Court ruled that the property owners, through the Colonial ordinances, own their land to the low tide mark. While I was opposing that decision, I respected the law court's decision that they made and have since accepted that. That decision has been made in several cases up and down the Maine coastline, including the ones with the rockweed, including goose rocks, and including several others that say that the property owners have the right to their property. The biggest problem with this issue is if we pass this bill this will open up an enormous legal battle that will initially shut down the coastline of Southern Maine as property owners will take offense to this and will put up the no trespassing signs at the height of our tourist season. The town of Wells and many coastal towns in Southern Maine with coastal properties where sandcastles, walking, and sunbathing can be

done is because property owners and the towns work well together, cooperatively. To take a legislative Body to force them, to make them do that, will simply create a legal battle for which I don't think we or the State want to engage in. This is a takings of private property and the Constitution does clearly state that if we're going to take it by legislative fiat we need to pay for it.

We all received an email from a gentleman in Kittery who writes five very eloquent reasons why we shouldn't pass this, but one I will read for the record. His third one is from the legal perspective, 'L.D. 1323 raises Constitutional questions on Article 1, section 21, of the Maine Constitution, the act would amount to taking of private owned lands without compensating the private property owners. The law states private property shall not be taken for public uses without just compensation nor unless the public egress require it. L.D. 1323 may be in direct violation of the Maine Common Law which holds that coastal property owners own land out to the mean low tideline with a public easement restricted to only fishing, fowling, and navigation.' That was a decision of the Maine Supreme Court and it has held that in several cases that declared coastal intertidal zone belonging to the property owner. I would urge this Body not to pass this law. There was a simple solution to the problem with the rockweed. They could have entered into lease agreements with the property owners to harvest the rockweed under restricted covenance so that they could control how much was being harvested and that would have solved this problem. But instead they went to the courts. The courts, from the lower courts all the way up to the Supreme Court, ruled for the property owner and I don't think that, as the third Body of government, we should be interfering with the Judicial decisions. Thank you, Mr. President.

**THE PRESIDENT:** The Chair recognizes the Senator from Lincoln, Senator Dow.

Senator **DOW:** Thank you, Mr. President. I listened to the testimony. This bill is not about taking the land. This is regarding the public trust of the intertidal zone. The courts already agree that the property owners own the land but the public trust has to do with the rights of people to fish, fowl, and to navigate. When these rules were come across, invented, many centuries ago the taking of seaweed was not an industry back then. The public trust regards, we have a public trust because of the clamming industry, the worming industry, and other industries that hold the rights to those products because the land is held in a public trust. This bill originally was asking that we put seaweed as part of this public trust. The Committee Amendment added other things that had to do with recreation. But you can already clam in the intertidal zone. You need licenses from the town to do so. You already can do worming in the intertidal zone and there are other activities. You can hunt from the intertidal zone. You can fish from the intertidal zone. You can scuba dive because that's considered navigation. But under our antiquated rules you're not allowed to take seaweed.

I don't know if any of you, I'm not a gardener. I don't have a green thumb but I did have a person teach me the proper way to prune a bush and he said, 'If you get inside the bush and cut out all the dead material and open it up for the sunlight it will really grow.' Well, that's what happens when we cut part of the seaweed off. It opens up the bottom to sunlight and seaweed grows back even more and provides an even better area for all creatures that grow up in there also. So this bill originally was about asking for the right for people to get the seaweed and so I

would ask that you would follow my light and vote for this Committee Amendment "A".

**THE PRESIDENT:** The Chair recognizes the Senator from Kennebec, Senator Bellows.

Senator **BELLOWS:** Thank you, Mr. President. Ladies and gentlemen of the Senate, I rise in opposition to the pending motion. I grew up in Hancock County, a couple of miles from the shore, and I spent my childhood on the coast. There are some misconceptions about what rockweed is and what role it serves in the ecosystem. Rockweed is the seaweed, the long strips that have the bubbles. It is fundamental to the ecosystem of our coast and it might not be a surprise to you that I was so passionate about marine biology that I worked for several years at the Mount Desert Island Biological Laboratory as a research assistant. So what I will say to you is that properly harvested rockweed is not a problem in the least bit, but some of what is happening is machine harvesting, stripping entire sections of rockweed, or repeated cutting of this resource. It takes 15 years for regeneration and will only regenerate if harvested appropriately. It could have catastrophic impact on our intertidal zones. Remember, in those tidal pools, rockweed creates and supports an ecosystem for our small crabs, for crustaceans, for the snails, and things that create and support our larger marine resources and some of our most important industries.

Now the most recent court case came about because a Canadian company was harvesting rockweed in Washington County and a landowner asked them to stop because of the techniques that they were engaging in and the harvester refused to do so. Now this is a company that employs only five people in Washington County and was seeking to strip this rockweed from this precious ecosystem. So that's where the court case started. I would just say that I know this is an important industry and responsible harvesters can get permission from landowners and work in collaboration with landowners to do this in responsible and ecologically sustainable ways. I would further say that in the absence of the law court decision, and should we move forward with this bill, there will not be sufficient checks and balances. In the '90s, growing up in Hancock County, the sea urchin industry was hot. It was a huge boom. There were a lot of jobs. People made a lot of money with sea urchins. Now there are no sea urchins. That industry has completely decimated. I would hate for our passage of this bill to result in a similar boom and bust cycle of the rockweed industry in our state. When the Maine Farm Bureau, the Maine Realtor's Association, the Nature Conservancy, and the Natural Resources Council of Maine joined together to ask us to support legislation because the Committee Amendment has become so complex and so objectionable to so many parties I think we should be very cautious about moving forward and overturning a law court precedent in this large and complicated way. I urge you to vote Ought Not to Pass.

**THE PRESIDENT:** The Chair recognizes the Senator from Washington, Senator Moore.

Senator **MOORE:** Thank you, Mr. President. Ladies and gentlemen of the Senate, I would like to read to you a letter from the Attorney who represented Ross, the brothers, in the Acadia Sea Plant. In his opinion letter that he wrote to Christopher Nolan, the Director of the Office of Fiscal and Program Review, concerning the fiscal consequences of L.D. 1323. As I quote, he

says, 'I am writing regarding L.D. 1323, An Act to Revise the Laws Regarding the Public Trust in Intertidal Lands. L.D. 1323 was passed out of committee without any analysis of its fiscal impact, which would be substantial. Specifically, L.D. 1323 would result in multiple takings of private intertidal property rights that would require the State to pay just compensation to landowners along the entirety of Maine's coast. On its face, L.D. 1323 would grant to the public the right to conduct nearly any recreational or commercial use on private intertidal property. L.D. 1323 sets forth a number of uses of private intertidal land as examples of rights that it would grant to the public. However, the majority of the activities that L.D. 1323 would permit have been held by the Maine Supreme Judicial Court to be beyond the scope of the public's right to use private intertidal property. Most blatantly, L.D. 1323 states that the public is permitted to engage in seaweed harvesting on all intertidal land in the state. Just two months ago, the law court unanimously held the opposite. Rockweed attached to and growing in the intertidal zone is the private property of the adjacent upland landowner. Harvesting rockweed from the intertidal land is therefore not within the collection of rights held in trust by the State and members of the public are not entitled to engage in that activity as a matter of right. The Office of the Attorney General submitted written comments on L.D. 1323 stating the majority of the commercial uses set forth in L.D. 1323, which include the harvesting of seaweed, are not, or may not, be within the public's trust right. Accordingly, the OAG recommended deleting the entirety of L.D. 1323's provision purporting to grant the public the right to conduct commercial uses, including rockweed harvesting, on private intertidal land. The OAG's comments are attached to this particular letter. Thus, under common law, the public unequivocally does not have the right to harvest rockweed on private intertidal property. While it is true that the legislation has the authority to codify, alter, or advocate the common law, legislation that results in a taking of private property rights requires the State to pay just compensation. L.D. 1323 would cause a taking of, among other property rights, privately owned intertidal rockweed up and down the Maine coast. In order to accomplish that taking, the State would need to compensate every intertidal landowner whose land contains rockweed. Although rockweed is not a high value resource, it sells for about 4¢ a pound at the dock, a 2001 University of Maine study estimated that there are approximately one million metric tons of wet intertidal rockweed in Maine. That works out to be a very rough estimated dock value of \$88,184,000. That estimate does not appear to account for the rockweed growing on the significant coastline of Maine's islands. In addition to the compensation specific to the State taking of rockweed, L.D. 1323 would result in multiple other takings. If enacted, the statute would allow commercial uses, including but not limited to infrastructure related to aquaculture, fish, shellfish, and other marine organisms; instillation of utility cables and pipelines; and the storage, rental, and sale of paddleboats and surfboards, kayaks, small boats, and related marine equipment on private intertidal property. Finally, the recreation use provision in L.D. 1323 is functionally the same as the 1986 intertidal recreational use statute that was invalidated as an unconstitutional taking in *Bell vs. Town of Wells*. L.D. 1323 would simply replace the invalidated recreational use in statute with new recreational use that suffers from the same constitutional defect, mainly the taking of property rights without just compensation. As discussed above, the majority of L.D. 1323 will require substantial State payment of just compensation

to landowners and will result in unconstitutional, non-compensated takings.' I encourage you to vote against L.D. 1323, the motion that's on the Floor. Thank you.

**THE PRESIDENT:** The Chair recognizes the Senator from Penobscot, Senator Guerin.

Senator **GUERIN:** Thank you, Mr. President. Mr. President, ladies and gentlemen of the Senate, harvesting the bounty of the sea is a Maine tradition in the intertidal zone. Passing this bill will protect the jobs of 4,900 license holders of marine organisms that are regulated by the Department of Marine Resources. My son and his wife were seaweed harvesters before ocean harvesting was shut down. This was not something that was environmentally dangerous. I went out with them one hot summer day and thought I would try my hand at harvesting, and I can tell you it is very hard work. They use a rake that is a long-handled rake which is kind of thrown out into the water. They let me have a try at it and I could barely lift the rake into the boat. I was like, 'I don't know how you guys do this.' But they are like many Mainers, Downeast in Washington County, kind of free spirits that want to live life on their terms. They had entered into an agreement to buy a house from an owner down there and planned to live in Washington County. Washington County certainly needs more young families. But when the zone was shut down for their raking, this week they were forced to move to Rhode Island where my son, Peter, will be fishing offshore five days a week on a boat out of Rhode Island. So I would support the passing of this bill to bring my family home.

**THE PRESIDENT:** The Chair recognizes the Senator from Knox, Senator Miramant.

Senator **MIRAMANT:** Thank you, Mr. President. Men and women of the Senate, this was one of those bills that I thought would start its way through the Agricultural Committee based on the submerged lands portion that was argued, that would find its way to the Marine Resources Committee where it should have had a consideration as well. We deal with these issues. We have presentations from the harvesters. We have regularly scheduled meetings with the different folks that fish, that harvest, that process. We have a body of knowledge to work. So I saw no way that this would stop in Agriculture, but it did and here's the recommendation. This recommendation falls short of all the areas that should have been considered. I want to encourage the landowners to work with the harvesters and get permission and make sure that best practices are followed. I don't want to see a law pass just so we can give the Supreme Court something to argue about. They'll find plenty of things to argue about. Let's get a good bill that works on the things we need and fix the things that need to be fixed and find ways to work together to do the best stewardship of our resources. As my colleague pointed out, we don't have a great track record with this. We need to very finely tune any fishery, any harvesting, anything that has to do with our oceans because we have decimated so many things in our oceans and we're not going to get a lot of second chances. Thank you.

**THE PRESIDENT:** The Chair recognizes the Senator from Penobscot, Senator Dill.

Senator **DILL**: Thank you, Mr. President. Ladies and gentlemen of the Senate, I just want to make a couple of quick points. First is that the Attorney General does not see this as a takings bill and also I think it's been mentioned that there was a fiscal note. There is no fiscal note on this bill either. Just a couple of points of clarification. Thank you.

**THE PRESIDENT**: The Chair recognizes the Senator from Kennebec, Senator Cyrway.

Senator **CYRWAY**: Thank you, Mr. President. Ladies and gentlemen of the Senate, this bill contradicts what we did with fiddleheads. It's attached to the ground. It grows. Same thing with the seaweed, the rockweed. It's attached to the rocks. It grows. What we're doing here, we should just have the land leased. If you're going to do a crop you lease the land. It would be very simple. This bill takes away that and we should not. I'm against this bill because of that reason. Thank you, Mr. President.

**THE PRESIDENT**: The pending question before the Senate is Acceptance of the Majority Ought to Pass as Amended Report. If you are in favor of accepting that report you will be voting yes. If you are opposed you will be voting no. Is the Senate ready for the question?
