**Joint Resolution**

The following Joint Resolution:

H.P. 1397

**JOINT RESOLUTION MEMORIALIZING THE PRESIDENT OF THE UNITED STATES AND THE UNITED STATES CONGRESS TO REVIEW PORTIONS OF THE NATIONAL DEFENSE AUTHORIZATION ACT**

WE, your Memorialists, the Members of the One Hundred and Twenty-fifth Legislature of the State of Maine now assembled in the Second Regular Session, most respectfully present and petition the President of the United States and the United States Congress as follows:

WHEREAS, the United States Congress passed the National Defense Authorization Act for fiscal year 2012 on December 15, 2011, and the President of the United States signed the Act into law on December 31, 2011; and

WHEREAS, the Act directs the Armed Forces of the United States to detain any person who is captured in the course of hostilities authorized by the federal Authorization for Use of Military Force Against Terrorists and who is determined to be a member of or part of al-Qaeda or an associated force that acts in coordination with or pursuant to the direction of al-Qaeda and to have participated in the course of planning or carrying out an attack against the United States or its coalition partners; and

WHEREAS, the disagreements and uncertainty in interpretation of the law has raised significant concerns about due process for United States citizens; and

WHEREAS, the prospect of the indefinite detention of United States citizens violates, without due process of law, basic rights enshrined in the United States Constitution, such as the right to seek a writ of habeas corpus, the right to petition for a redress of grievances, the right to be free from unreasonable searches and seizures and the right to counsel; and

WHEREAS, it is crucial to national security that funding contained in the National Defense Authorization Act for the Department of Defense and members of the military and their dependents remain intact; and

WHEREAS, the members of this Legislature have taken an oath to uphold the United States Constitution and the Constitution of Maine; now, therefore, be it

RESOLVED: That We, your Memorialists, most respectfully urge and request that the President of the United States and the United States Congress amend the National Defense Authorization Act to clarify that any provisions contained within will not deprive United States citizens of the rights of due process; and be it further

RESOLVED: That suitable copies of this resolution, duly authenticated by the Secretary of State, be transmitted to the Honorable Barack H. Obama, President of the United States, to the President of the United States Senate, to the Speaker of the United States House of Representatives and to each Member of the Maine Congressional Delegation.

**JOINT RESOLUTION IN HONOR OF WOMEN'S HISTORY MONTH AND IN RECOGNITION OF THE CONTRIBUTIONS THAT WOMEN MAKE TO MAINE AND TO THE UNITED STATES**

WHEREAS, American women of every race, class and ethnic background have made historic contributions to the growth and strength of our nation in countless recorded and unrecorded ways, especially in the areas of political and social change; and

WHEREAS, the United States boasts a rich history of women whose vast and courageous achievements speak to the sense of excellence and potential shared by all Americans; and

WHEREAS, our country would not have attained its greatness without the strength, bravery, insight and persistence of the women who have come before us; and

WHEREAS, American women have played, and continue to play, critical economic, cultural, political and social roles in every sphere of the life of the nation by constituting a significant portion of the labor force working inside and outside of the home and in professions from educator to astronaut; and

WHEREAS, women have played a major role in the defense of our nation, both on and off the battlefield; and

WHEREAS, American women have been leaders, not only in securing their own rights of suffrage and equal opportunity but also in the abolitionist movement, the emancipation movement, the industrial labor movement, the civil rights movement and other movements that create a more fair and just society for all; and

WHEREAS, women not only have played critical economic, cultural and social roles in our society but also have permanently changed the face of American government and politics; and

WHEREAS, Maine has a rich and vibrant history of women in leadership, including former Senator Margaret Chase Smith, perhaps best known for her contribution to the well-being of the United States and its people with her consistent stand for the condemnation of bigotry and injustice wherever she found them; and

WHEREAS, Senator Margaret Chase Smith was the first woman from Maine to serve in the United States Congress, the first

woman in the nation elected to both houses of the United States Congress and the first woman to be placed in nomination for the presidency at a major party's convention; and

WHEREAS, Maine currently has some of the strongest women leaders in the nation, including Senator Olympia J. Snowe, the first woman to serve in both houses of a state legislature and both houses of the United States Congress, and Senator Susan Collins, the first woman to run for Maine Governor from a major party; and

WHEREAS, within our state judicial system, Chief Justice Leigh I. Saufley is Maine's first woman Chief Justice of the Supreme Judicial Court; and

WHEREAS, we must take every action possible to promote women in leadership so that we can achieve fair representation in our State Government, including recognizing Maine women's contributions to our state history; and

WHEREAS, in recognition of the contributions of women, the United States Congress has passed a resolution each year since 1987 designating the month of March as "Women's History Month"; now, therefore, be it

RESOLVED: That We, the Members of the One Hundred and Twenty-fifth Legislature now assembled in the Second Regular Session, on behalf of the people we represent, take this opportunity to recognize March 2012 as Women's History Month in Maine; and be it further

RESOLVED: That We encourage the residents of this State to observe Women's History Month by participating in programs, ceremonies and activities to foster an awareness of and appreciation for the contributions made by women that have benefited and improved society.

**READ.**

**THE PRESIDENT:** The Chair recognizes the Senator from Androscoggin, Senator Craven.

Senator  **CRAVEN:** Thank you Mr. President. Men and women of the Senate, March is Women's History Month. It's International Women's History Month, actually. Each year the National Women's History Project selects a team that highlights achievements by distinguished women in specific fields from medicine and the environment to art and politics. The 2012 theme, "Women's Education - Women's Empowerment", pays tribute to the pioneering teachers and advocates who help women and other groups gain access to advanced learning. Honorees include Emma Hart Willard, a higher education pioneer; Charlotte Forten Grimke, an educator and advocate for the education of African Americans; Annie Sullivan, a disability education architect known for her work with Helen Keller; Gracia Molina de Pick, a feminist educational reformer; and Brenda Flyswithhawks, an American Indian educator.

International Women's Day, a global celebration of the economic, political, and social achievements of women, took place for the first time in March 1911. Many countries around the world celebrate holidays with demonstrations, educational initiatives, and customs, such as presenting women with gifts and

flowers. I really wish to initiate that here and would love to have gifts and flowers for all of us women. The United Nations has sponsored International Women's Day since 1975. When adopting the resolution on the observation of International Women's Day, the United Nation's General Assembly cited the following reasons; to recognize the fact that securing peace and social progress is the full enjoyment of human rights and fundamental freedoms require the active participation, equality, and development of women and to acknowledge the contributions of women to the strengthening of the international peace and security.

In recent weeks, on the national level, women have been, I think, dishonored and disparaged from trying to take their healthcare services away, and to calling them names when they have the courage to stand up and to speak up about their convictions. I'm not going to do a lot of preaching about that, but I would invite everybody to think of their mothers, their spouses, their sisters, their daughters, their granddaughters, their best friends, any friends, people that they work with, and young women in our community who deserve our complete honor and our complete respect for what they do and the fact that they are, indeed, created in God's image. I hope that on a grassroots level we all stand up to honor women in our society who have just been so very, very instrumental in creating our society, our educational fields, and everything that we have. Thank you, Mr. President.

**THE PRESIDENT:** The Chair recognizes the Senator from Cumberland, Senator Bartlett.

Senator **BARTLETT:** Thank you Mr. President. I, too, support this Resolution. It recognizes the outstanding contributions of women to our state. I wanted to add a few other women to the list of those who have been noted in the Resolution who I think deserve a special mention today. One of those is former President of this Body, Libby Mitchell, who has had the honor of serving as the first woman Speaker of the House and then became the first woman in the country to serve as a Presiding Officer of both branches of the Legislature. We also had the good fortune in Maine recently of electing Janet Mills as our Attorney General. She is the first woman to serve in that post and did an extraordinary job. My congresswoman, Chellie Pingree, who is the first Democratic woman to be elected to Congress. Those are a few of the people who have inspired me along the way and I wanted to be sure to honor them. I also wanted to offer a brief note about Margaret Chase Smith. My mother was always a very strong influence on me. Her first job out of high school, she graduated from Oxford Hills High School and went through their business program, was to go to Washington and work for Margaret Chase Smith, which was a great honor for her and a great honor for our family. In that time, Margaret Chase Smith liked to hire folks right out of high school because she wanted to train them herself. She wanted to make sure that they did things the way she thought they ought to be done. She was very, very involved and active with her staff. She always took great pride in the fact of sending money back that she was allocated for her staff and her offices because she took pride in being frugal. She found out that my mother could sew and decided that she would take advantage of that as well. My mother recalls making a dress for her, making a slipcover for one of her couches, and, in fact, even shopping for clothing for her. She says today that she has no idea how she had the audacity to do it at that time, but certainly it was a thrill of her life, and sent her down a path of

having a very distinguished career as a legal secretary here in the state of Maine. Thank you, Mr. President.

**THE PRESIDENT:** The Chair recognizes the Senator from Penobscot, Senator Schneider.

Senator **SCHNEIDER:** Thank you Mr. President. Men and women of the Senate, I would also like to stand and thank all the women who came before me, who made it possible for me to be here today. Without people fighting for equality, fighting for women to vote, and all the different struggles that women have gone through, I would not be standing here today. I also want to thank my mother for being such a strong role model for me, making me feel secure in myself, and with the knowledge that I could achieve anything I put my mind to. I also want to just point out, as we go forward, that we have a long way to go as women in achieving equality. I remember very vividly, when I was listening on the Maine Public Broadcast network, about how many years it would take for women to achieve gender equality in Congress. It was astounding at the current pace that we are going. It was in the many hundreds of years for women who are Caucasian to achieve gender equality, and it would be something like 700 or 900 years before of color would achieve gender equality in Congress. We continue to struggle with equal pay for equal work. For example, I believe we only make, as women, something like 75¢ on the dollar to men for the very same work that they achieve. We continue to be discriminated against. As we move forward, I hope we will all fight for gender equality and fight for equality when it comes to monetary payment for the work that we all do going forward. We have a long way to go. We have certainly come a great distance, but I think today can highlight that we are very much a part of this society and we should be treated equally. Thank you very much, Mr. President.

**THE PRESIDENT:** The Chair recognizes the Senator from Penobscot, Senator Plowman.

Senator **PLOWMAN:** Thank you Mr. President. Men and women of the Senate, I, too, rise in support of this Joint Resolution. When I think of women who are getting things done, I still go back to my grandparents and my grandmothers because they did the everyday stuff without knowing that they had a sisterhood, without knowing that someone would be out there making huge changes. They did it every single day and they instilled in their children, men and women, a sense of what was right and what was wrong. As we go forward, I know that I have helped instill that in my daughter who, in her travels, decided to go school in the South. I cannot tell you the distress that I hear in her voice when she calls to tell me how a friend of hers has been beaten up and the police officer says, "I've seen worse," or when one of her Black roommates is not allowed to go to a fraternity house because she's Black. As we stand here in the Maine State Senate, please know how lucky we are, as women, to have the respect of our peers and the respect of our families, and know that we are not done yet, even on the little things that we don't talk about. Right now we talk about equal pay and we talk about Congress. We talk about being elected when there are young women, right now, still trying to get someone to pay attention because their boyfriend beat them up or because they are not the right color. We have a lot of work to do and it starts with taking the lessons that we've learned and passing them down to our daughters and our sons and insuring that we do continue because, even with the big

things that are out there, we still have so many little things left to do to make life good for so many young women who are coming along. Thank you, Mr. President.

**THE PRESIDENT:** The Chair recognizes the Senator from Cumberland, Senator Dill.

Senator **DILL:** Thank you Mr. President. Men and women of the Senate, I rise also in support of this Joint Resolution and as a tribute to a woman who I greatly admire and who spoke at the 4<sup>th</sup> U.N. Conference on Women, Hilary Rodham Clinton, who said to the world in 1995, "What we are learning around the world is that if women are healthy and educated their families will flourish. If women are free from violence, their families will flourish. If women have a chance to work and earn as full and equal partners in society, their families will flourish. When families flourish, communities and nations do as well. That is why every woman, every man, every child, every family, and every nation on this planet does have a stake in the discussion that takes place here." With that, I thank you very much.

**THE PRESIDENT:** The Chair recognizes the Senator from York, Senator Sullivan.

Senator **SULLIVAN:** Thank you Mr. President. I also rise in support of this Resolution. As a teenager in high school, I was taken aside and told, "Now, with your grades", I was in that time what was called college prep courses, "Would you like to be a nurse or a teacher?" Those were my two choices. I'm old, but I don't think I'm that old. To be given two choices because I was in college prep. The reason why I was given those two choices was because it was assumed I would get married, have children, and if anything happened to my husband I could always either go into nursing or teaching. I would confess today that I would not have taken that path, but at the time I didn't realize I had a voice. I could have said, "I don't want to do either. I want something different." I never fulfilled that dream. It bothers me. Today I don't want that to happen to any of the kids. The 7<sup>th</sup> graders that I taught should never be given a choice between one profession or the other simply because of their gender. I was fortunate. I had two older brothers growing up. If you want to find out how you would live in a world full of men, grow up and be the baby sister of two older brothers who continue to this day to be pains most of the time. They taught me a lot about surviving. They taught me a lot about standing up for myself. I owe much of my success to my two brothers. It sort of goes against, "Behind every good man there is a woman pushing him." I would have to say one other thing, I would not be able to do this job without the support of men. My husband has been terrific to me. Men, as you sit here hearing all these things about women, you need to know that we make you look good. I would dare any man in this Chamber to stand up and say differently right now, on the record. As I look at the young women visiting us today and as I look at the women now in our hallways, we have come a long ways, baby, but we have not come far enough. We need to continue to work, relish the past, and continue to work to the future. Thank you very much, Mr. President.

**THE PRESIDENT:** The Chair recognizes the Senator from Androscoggin, Senator Snowe-Mello.

Senator **SNOWE-MELLO:** Thank you Mr. President. I also stand today in support of this Resolution. I'm thinking back to my grandmother. My grandmother, who Ella Steinbauch. She came over from Germany when my mother was just a little girl. Ella was quite the woman. She didn't think about being immigrant from Germany. She was a very, very strong woman. Ella immediately decided, upon coming to this country, that they were going to learn English. She was really the breadwinner of the family way back, and this was in the 1920's. My grandmother, who I called Modgie, was quite something. She would often have to leave home and travel to other states to do nursing while my grandfather stayed home with my mother. He also worked, he worked in a mill. My grandmother really was a great role model for my mother. When my Mom married and had children, she taught us all to believe in ourselves and not to let anyone say that you can't do anything. My Dad said, because I had a problem physically, just like the good Senator from York would say, "You can only be a teacher or can only be a nurse." My mother would say, "You can do anything you want to do." Even though my mother didn't work, that was her choice. She taught my sister and I to really believe in ourselves and that we could do anything. Looking forward to today, I am very blessed that I have a wonderful husband who had a very strong mother. His mother taught my husband, Brian, to be very respectful of women. Because of him, he has encouraged me to continue on with my occupation. I also say to the good Senator from York, Senator Sullivan, I'm so glad that you did become a teacher because I think your children were very blessed to have you. I think that women have really advanced through the years. Look how many executives that we have in this country, top notch executives who are women. I think we have to be very proud and very comforted. We have come a long way, baby. Thank you.

**THE PRESIDENT:** The Chair recognizes the Senator from Cumberland, Senator Brannigan.

Senator **BRANNIGAN:** Thank you Mr. President. Men and women of the Senate, women's history is a history of struggle. Sorry, but they don't need gifts and they don't need flowers. They need equity and they need justice. If you want to study the power of the woman's movement, look to the temperance movement. You don't have to agree with the outcome. It wasn't good overall. The power of women in those late 1800's and the early part of the last century, the 1900's, was overwhelming. The power of women, who couldn't even vote, had great influence on how the temperance laws came into effect. Of course Maine was a leader, I'm sorry to say. It blended in with the Civil Rights movement in those days and eventually their ability to vote. I was interested in this in a book called Last Call. Inequity, I'm sorry if I offended anybody and they left. Thank you very much, Mr. President.

**THE PRESIDENT:** The Chair recognizes the Senator from York, Senator Hill.

Senator **HILL:** Thank you Mr. President. Ladies and gentlemen of the Senate, I rise in support of the Resolution. I also am in accord with everyone that has been referenced to so far. I would just like to remind you that you don't have to look far beyond this room to find women to honor. I would ask the males in the room, my male peers, to join me in honoring Senator Craven, Senator

Dill, Senator Farnham, Senator Plowman, Senator Schneider, Senator Snowe-Mello, and Senator Sullivan. Thank you.

Senate called to order by the President.

**THE PRESIDENT:** The Chair would add the name of Senator Hill. The Chair recognizes the Senator from Cumberland, Senator Gerzofsky.

Senator **GERZOFSKY:** Thank you Mr. President. Ladies and gentlemen of the Senate, a little history is due. Back in the late 1970's and early 1980's there was a movement called the ERA, the Equal Rights Amendment, that came through the country to change the Constitution. It didn't fulfill its dream of two-thirds of the states, but Maine was a state that not only the people voted for it, but so did the Legislature. There happen to be a couple of legislators sitting here today that actually voted for that. I remember when we passed it here in the Senate. I was on staff. It was done with quite a lot of fanfare and emotion. We had several women serving here at the time. I dare say maybe more than we have now. It was a very big day in the history of equal rights for women and the people of Maine have always believed in equal rights for all and here in the Senate it's the same, and in the House. Thank you, Mr. President.

**THE PRESIDENT:** The Chair recognizes the Senator from Lincoln, Senator Johnson.

Senator **JOHNSON:** Thank you Mr. President. Ladies and gentlemen of the Senate, I would like to add two noteworthy women. First, Frances Perkins who, in a position not foremost of power but a voice of a great deal of influence through her work with others, achieved great things in worker conditions, safety, and Social Security, which so many of our elderly rely on to keep them from destitution in their old age, were enacted because of her work behind the scenes in this country. I remark that much of the work of women has been behind the scenes and not given the recognition that it should have. In my own life, a women that had made a difference, besides my mother who taught me a lot about being a good person and believing in ethics and the golden rule, and she also showed me that acceptance and love make a huge difference in a person's life, was an English teacher I had in Bangor High School, who had spent some time with her husband, who was a doctor, before it was generally open for that sort of travel, in China. Actually on one occasion she spoke to us, in her class with just the young folks, about how we should not take the liberties that we have for granted because she had seen how people lived in less free societies. I think that women do need flowers, but they need it because we appreciate what they do for us. They need more than flowers, because they deserve our respect and equal justice as well. Thank you.
